

The Physics Research Promotion Centre, which is part of the National Science and Technology Council (NSTC) and IOP Publishing have signed a transformative agreement on behalf of participating universities in Taiwan to facilitate open access publishing.

Your library is participating in this agreement, meaning that readers at your institution will be able to access to more than 100 journals in physical sciences, as well as research accepted for publication by corresponding authors at your institution will be published on an open access basis.

### How to publish under an agreement

### It's as simple as this:

**Publication** 

**Article submission** Author submits manuscript to an eligible journal

**Identification** IOP automatically identifies article and informs corresponding author of inclusion

Agree CC-BY Author agrees to open access via CC-BY licence

If accepted for publication, article will be published open access under the agreement

### How to publish under the agreement

- We identify that articles are eligible using the affiliation of the corresponding author
- To be eligible, the article should be accepted within the licence term
- During the peer-review process, or shortly after acceptance we will write to the corresponding author to let them know we will publish the article open access
- Articles are automatically opted in to open access. Although the author can still opt out, this is very rare.




The corresponding author is the one that submits the manuscript, and is responsible for communicating with the journal during the submission, peer review and publication process.

### **Author Guide**



When ready to start the submission, follow steps 1-4 on our submission system; **ScholarOne.**

### **Providing author information**

#### Step 4: Author Information

Please enter information for all' co-authors, ensuring names, emails and affiliations are accurate. Changes to author lists after submission are only made in exceptional circumstances and are subject to approval by editorial staff.

More advice and support on adding author information is available, including who should be listed as a co-author, how to check if your co-author already has an account, and quidance for names with Chinese, Korean or Japanese characters.

Please do not share your login details with co-authors, who will receive their own login information if they do not already have accounts with the journal.



### Signing copyright

The author will be asked to sign an open access copyright form and once the article is accepted it will be published open access under the terms of the institutional agreement.



### Identification



- Identification is always based on corresponding (submitting) author
- We use historic submission data to inform the identification process
- Automatic authors do not need to do anything
- We proactively sweep for missed opportunities
- Articles can be made OA retrospectively, as and when they come up authors have to agree
- Wherever possible we make librarians aware of author opt-outs in real time





#### 轉換協議的四個迷思

越來越普遍的一種提供開放取用出版的方式,是通過轉換協定(TAS)。 這些出版商與大學之間簽訂合約,將文章出版費(APCs)合併到訂閱協 議中,同時符合開放取用資助機構的要求。

轉換協議使研究人員能夠在不必自費支付 APC 的情况下,將其研究成果以開放取用形式發表,儘管開放取用出版的莊康令人信服,但仍有一些研究人員,不知道自己有資格透過轉換 被信用放取用出版,或選擇不這樣做,這通常是由於誤解或認識錯誤,在轉換協定的複雜性方面,之其如此,在此。我總結了其中的四個方面;

#### 迷思: 通過轉換協議出版開放取用文章更加困難

事實恰恰相反。轉換協議為研究人員消除了兩個最大的難題:開放取用的前期成本,和 繳納費用的行政工作。轉換協定提供了集中化的工作流程,費用事宜由團書館進行管 理。轉換協議獲使作者能夠在混合型期刊(在大多數領域,大部分研究仍由進一類型期刊 出版)發表文章,同時遵守資助機構的開放取用政策。這意味著許多研究人員可以在自己 擴揮的期刊中發表文章,而非頻擇全面開放取用型期刊。

#### 迷思:對作者而言,發表開放取用文章更加昂貴

在當前的開放取用出版模式下,研究人員通常得到其所屬機構或研究資助機構的財務支援。可以使其研究成果供免費閱讀。但他們需要透過支付文章出版費用(APCs)來承繼出版費。

轉換協議將訂閱費用和 APCs 結合在一起,使機構可以獲得折扣,與傳統開放取用路線相比,大大降低了開放取用出版的成本。

IOPP 還推出 APCs 減免政策,以支持那些來自可能無法支付費用的大學或地區的作者。
